

**ORDINANCE NO. 3620**

**AN ORDINANCE AMENDING 3054 SECTION 12.28.050, 12.28.060, 12.28.070, AND 12.28.080 OF THE FORT SCOTT MUNICIPAL CODE DEALING WITH BOATING FEES OF THE CITY OF FORT SCOTT, BOURBON COUNTY, KANSAS.**

**BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF FORT SCOTT, BOURBON COUNTY, KANSAS:**

**ORDINANCE 3054 SECTION 12.28.50 is amended as follows:**

**SECTION 1 12.28.050**      **- MOTORBOAT LICENSE APPLICATION FEE**, shall be amended to read as follows:

A license fee for the operation of a motorboat shall be paid to the City Clerk on an annual basis. The yearly license fee for all persons for motorboats of less than 25HP shall be \$15.00, and for motors of 25HP or more, \$25.00. The amount of horsepower (HP) shall be determined by the manufacturer's ratings.

**SECTION 2 12.28.060**      **MOTOR LICENSE TEMPORARY FEE**, shall be amended to read as follows:

A. Persons not desiring to buy an annual license fee shall be permitted to purchase a temporary license upon the same terms and conditions as the annual license for a period of two (2) days. The fee for a temporary license shall be \$5.00 for motors of less than 25HP and \$10.00 for motors of 25HP or more.

B. Persons who are engaged in the business of selling motorboats may obtain a yearly license which would allow the testing of such motorboats on Lake Fort Scott between the hours of 9:00 A.M. and 5:30 P.M. The fee for such license shall be \$75.00 per year.

**SECTION 3 12.28.080**      **ROWBOAT LICENSE APPLICATION FEE**, shall be amended to read as follows:

Persons desiring to operate a rowboat on the lake shall make application to the City Clerk and obtain a license therefore and the annual license fee shall be \$6.00

**SECTION 4 12.28.080**      **SAILBOAT LICENSE APPLICATION FEE**, shall be amended to read as follows:

Persons desiring to operate a sailboat on the lake shall make application to the City Clerk and obtain a license on the same form prescribed for the application for a motorboat license. Such license is required before the operation of any sailboat. The annual license fee shall be \$15.00.


**SECTION 5** All decals for watercrafts shall be displayed on right front of the hull clearly visible to everyone. Failure to display in this location shall be a violation of the municipal code and punished accordingly.

**SECTION 6** This ordinance shall take effect and be in full force from and after its passage, approval, and publication in the official City newspaper.
