

ORDINANCE NO. 3757

AN ORDINANCE AMENDING THE FORT SCOTT STORMWATER USER CHARGE AND REPEALING ORDINANCE NO. 3597 FOR THE CITY OF FORT SCOTT, BOURBON COUNTY, KANSAS, PURSUANT TO THE FORT SCOTT MUNICIPAL CODE, CHAPTER 13.24.121.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF FORT SCOTT, BOURBON COUNTY, KANSAS:

SECTION 1. The Fort Scott Municipal Code shall be amended by changing Chapter 13.24.121 – Waterworks and Sewage System Surcharge of the City of Fort Scott, Kansas and shall be as follows:

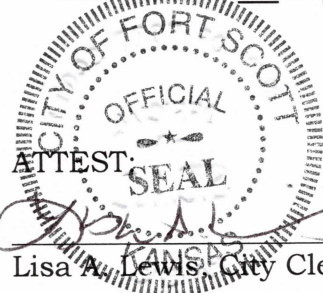
THE NEW RATES WILL BE EFFECTIVE THE FIRST FULL BILLING CYCLE IN JANUARY 2024. EACH YEAR THEREAFTER, RATES WILL AUTOMATICALLY INCREASE 3% AND WILL BE EFFECTIVE THE FIRST FULL BILLING CYCLE IN JANUARY.

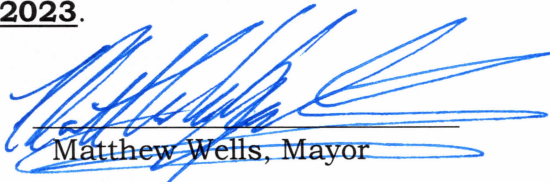

SECTION 2. This Ordinance shall take effect and be in full force after the passage and publication in the official City newspaper.

SECTION 3. ORDINANCE 3597 IS HEREBY REPEALED.
