

ORDINANCE NO. 3760

**AN ORDINANCE REPEALING AND REPLACING ORDINANCE NO. 3562 WHICH ESTABLISHES  
A FORT SCOTT STREET ADVISORY BOARD, PROVIDING FOR THE  
APPOINTMENT AND TERMS OF THE MEMBERS THEREOF, AND DEFINING THEIR DUTIES.**

**BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF FORT SCOTT, KANSAS:**

**Section 1. Created.** There is hereby established in the City of Fort Scott, Kansas, a Fort Scott Street Advisory Board for the purpose of recommending and advising the City Manager and City Commission on matters pertaining to the streets inside the City limits of Fort Scott.

**Section 2. Membership - Term.** That said board shall consist of five (5) voting members. At minimum three (3) voting members must reside within the City limits of the City of Fort Scott, and two (2) voting members who may reside within the three-mile radius of the City of Fort Scott's boundaries. The City Manager, and/or their designated representative(s) will serve as non-voting ex-officio's. As ex-officio, the staff member(s) will act as liaison(s) between City staff and the board. Additionally, the City Commission will appoint one (1) City Commissioner who will serve as a non-voting ex-officio. The appointed City Commissioner will act as a non-voting liaison between the City Commission and the board. Members residing within City limits shall be appointed by the Governing Body and their term shall be for three years. Members residing outside of City limits shall be appointed by the Governing Body and their term shall be for two years. Vacancies shall be filled by appointment for the unexpired term only. Board members shall serve without pay.

**Section 3. Election of Chairperson and Vice-Chairperson.** Within thirty days after passage hereof and on an annual basis, the board shall meet and organize its membership, electing two of its members as chairperson and vice-chairperson. Thereafter said board shall meet once each quarter, as well as at the request of the Mayor or City Manager or at the request of the majority of the members of said board, with the board establishing its own operating procedures.

**Section 4. Purpose.** The Fort Scott Street Advisory Board shall recommend and make suggestions to the City Manager and Governing Body regarding streets, street repairs, and brick streets located within the City limits of Fort Scott. In addition, the board shall make recommendations and reports to the Governing Body on all matters within a reasonable time after such request is made by the Governing Body.

**Section 5.** This ordinance shall be effective after its passage and publication in the official City newspaper.
