


## Local Rules

- Players may take free relief from newly planted trees, stance and swing, no nearer the hole.
- No players will start on No. 10 without clubhouse permission.
- Please keep carts on paths around tees and greens.
- Please observe all signs on course.
- Allow faster players through.
- Shirts must be worn at all times.
- Please repair ball marks and replace divots.
- Out of Bounds defined by white stakes. #17 tee shot out of bounds if it is to the right of the cart path in the right rough.
