

## **ORDINANCE NO. 3790**

**AN ORDINANCE AMENDING THE FORT SCOTT STORMWATER USER CHARGE AND REPEALING ORDINANCE NO. 3776 FOR THE CITY OF FORT SCOTT, BOURBON COUNTY, KANSAS, PURSUANT TO THE FORT SCOTT MUNICIPAL CODE, CHAPTER 13.24.121.**

**BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF FORT SCOTT, BOURBON COUNTY, KANSAS:**

**SECTION 1. THE FORT SCOTT MUNICIPAL CODE SHALL BE AMENDED BY CHANGING CHAPTER 13.24.121 – WATERWORKS AND SEWAGE SYSTEM SURCHARGE OF THE CITY OF FORT SCOTT, KANSAS AND SHALL BE AS FOLLOWS:**

**THE NEW RATES WILL BE EFFECTIVE THE FIRST FULL BILLING CYCLE IN JANUARY 2026. EACH YEAR THEREAFTER, RATES WILL AUTOMATICALLY INCREASE 3% AND WILL BE EFFECTIVE THE FIRST FULL BILLING CYCLE IN JANUARY.**

200,000 sq. ft. and up of impervious area \$107.83 per month


SECTION 2. ORDINANCE NO. 3776 IS HEREBY REPEALED.
